

Evansville IceMen Maniacs Booster Club

MEMBERSHIP CODE OF CONDUCT

The ECHL considers the IceMen Maniacs Booster Club to be an extension of the Evansville IceMen organization. As a member of the Booster Club, your conduct will reflect on both the booster club and the team as a whole. Therefore, in joining the Booster Club, all adults (18 and over) must agree to adhere to the following Code of Conduct:

1. Members agree to conduct themselves in a civil manner when representing the Booster Club, both at Booster Club functions and in general.
2. Members will not provide any additional compensation to players without ECHL approval, as this would be a clear violation of ECHL salary cap regulations. Members will not seek ECHL approval to do so, as approval can only be requested by the Board of Directors.
3. Members may not give any player goods or services that represent financial gain for the player, including but not limited to: secondary employment, season-long modes of transportation, or any gift of significant value. Regardless of how seemingly small you believe your action to be, purchasing or providing anything for a player can be deemed a violation of ECHL salary cap regulations.
4. Members cannot make cash donations or provide other gifts to the Booster Club for distribution to the players.
5. At no time will a Booster Club member provide or sell to any player any alcohol or drugs, prescription or otherwise, **for any reason**. If a member does so, they assume any and all liability associated with these actions, as per Section 6.4 of the Booster Club Bylaws. (Initials for all who sign below: _____)
6. Members shall employ common sense and courtesy in interacting with IceMen players and staff, both in person and online via social media. Interactions should remain friendly, limited in scope, and of reasonable duration. Even if unintentionally, members who become a nuisance will be subject to disciplinary action. If the Board of Directors feels that a member has repeatedly crossed the line, or if the IceMen office files a complaint, the member will receive one (1) warning prior to dismissal from the club (without refund). Outright harassment of any IceMen player or staff member shall be grounds for immediate dismissal from the club, without warning or refund.
7. As a member, you understand that if the IceMen organization believes that your conduct is of a detrimental nature in any way, the Booster Club has the right to investigate your actions and potentially request that you not attend any future Booster Club functions.
8. Each member is held personally accountable and responsible for their individual actions and the results of the same.
9. Members violating the Code of Conduct may be subject to termination of their membership without a refund.

NOTICE: Should violations be discovered by the league, the **TEAM** can be punished. The IceMen can be fined and could even have points deducted from the season standings!
